2. Report on Action Taken and Progress Made since 31stMeeting of the Governing Board held on Friday, 22nd July, 2016 at India International Centre Annexe, New Delhi

4. New Projects at the INFLIBNET Centre


The Members took note of the following new projects handled by the INFLIBNET Centre:

4.1 Development of Web Portal for National Institutional Ranking Framework (NIRF) - 2017

Development of Web-portal for the National Institutional Ranking Framework (NIRF), a prestigious initiative of the Ministry of Human Resource Development (MHRD) was awarded to the INFLIBNET Centre. The Centre developed portal to capture data required for ranking of universities, colleges and other institutions desirous of ranking themselves under various categories. The Centre also provides publications and citations data from Web of Science, Scopus and Indian Citation Index for more than 3,000 institutions that have applied for ranking themselves under NIRF.

4.2 SWAYAM-PRABHA

The SWAYAM-PRABHA, an MHRD project under NME-ICT, is conceived as a group of 32 DTH channels completely devoted to telecasting of high-quality educational programmes on 24x7 basis using the (2) GSAT-15 transponders. The INFLIBNET Centre has been assigned the task of developing a portal for SWAYAM-PRABHA and its hosting including archiving of videos telecasted on all channels. One of major component is SWAYAM-PRABHA Management system



where stakeholders namely channel coordinator, MHRD, BISAG personals use platform to interact with each other. The platform provides features of uploading of programme schedule by the channel coordinators, display of programme schedule (current, upcoming and archives), searching of econtent/videos using different kinds of filters such as channel-wise search and subject-wise search, and dashboard for MHRD, BISAG and admin view.

4.3 Food Safety Knowledge Assimilation Network (FSKAN): A project by FSSAI

FSKAN is conceived as platform designed to facilitate scientific co-operation amongst organizations by co-ordination of activities, exchange of information, development and implementation of joint projects. The INFLIBNET was assigned the task of developing a platform to assimilate all the information on single platform. The platform is being incorporated with different modules such as Expert Management System, e-Resources, Project Proposal System, discussion forum, etc.

5. International Conference on Knowledge Organization for Information Management: Collaborative Conference with SRELS, Bengaluru and RCIS, Chennai, October 23-25, 2017, Indian Institute of Technology, Chennai, India

After detailed discussions and deliberations, it was resolved that the INFLIBNET may become academic partner of the International Conference without committing to any financial assistance towards organization of the conference.

6. Presentation of the Proceedings of the 25th Meeting of the Finance Committee held on 10thMarch, 2017 at University Grants Commission, New Delhi
