The Minutes of the 33rd Meeting of the Governing Board of the INFLIBNET Centre held on 12th June, 2017 at India International Centre Annexe, New Delhi were confirmed as circulated, since no comments were received from the members.

2. Report on Action Taken and Progress Made since 33rd Meeting of the Governing Board held on Friday, 12th June, 2017 at India International Centre Annexe, New Delhi

7. Signing of MoU between INFLIBNET Centre and Central University of Himachal Pradesh

Members noted that the Centre has signed an MoU with the Central University of Himachal Pradesh with primary objective of starting a collaborative doctoral research programme wherein the students will enrol themselves for their Ph.D. programmes as per regulations with the Central University of Himachal Pradesh and conduct their research work at the INFLIBNET Centre or at both the institutions after completion of the period required for course work at CUHP. Members noted that the Central University of Himachal Pradesh has also shown interest for signing-up MoU with the INFLIBNET Centre and UGC for offering re-purposed courses with credits, developed by the INFLIBNET Centre under e-PG Pathshala, on SWAYAM.
